## **FINANCE REPORT**

Jim O'Grady (Chief Executive) spoke to Squash NZ's financial performance in 2013 / 2014. The year produced a surplus of \$26,655 after depreciation with Club Kelburn returning a better than budgeted return. Sundry income included income from the 2013 WSF agm held in Christchurch along with sales of hardware for online booking.

#### **BUDGET**

Jim O'Grady presented the budget for in 2014 / 2015.

Discussion points included

- A small deficit of \$2,304 was budgeted for the forthcoming year
- Affiliation income for 2014/ 2015 was budgeted at \$465,000 which was in line with previous years with a CPI adjustment. There were no issues foreseen with the collection of this amount.
- HPSNZ funding has not been confirmed and a reduction in income would have a major impact on some aspects of the HP programme for 2015 and beyond.
- The budget included income and expenses for a new commercial partnership role
- The national events budget included additional contributions to the PSA / WSA series in 2015

will be dealt with in accordance with the Squash New Zealand Anti-Doping Code as

amended from time to time.

18.1 The rules of Squash New Zealand for anti-doping shall be the Sports Anti-Doping Rules made by Drug Free Sport New Zealand, and as amended from time to

time.

18.2. To the extent of any inconsistency between the Sports Anti-Doping Rule and any rule in this Constitution or any policy, regulation or by-law of Squash

New Zealand, the Sports Anti-Doping Rules shall apply.

**Explanation:** 

The rule change clarifies and incorporates the disciplinary process for doping offences within the SNZ constitution and takes advantage of the services provided by Drugfree Sport New Zealand.

## SQUASH NEW ZEALAND AWARDS 2013 / 2014

The SNZ award winners for 2013/2014 were announced on the 28th and are -

#### **WORLD SQUASH FEDERATION REPORT**

Susie Simcock provided an update from the World Squash Federation annual general meeting and conference held in Philadelphia.

- Hugo Hannes and Mohammed El-Menshawy were re-elected to the WSF Board along with Linda McPhail.
   Gerard DeCourcy's bid for election to the Board was unsuccessful.
- There is some optimism that squash might yet be part of the 2020 Olympics. The IOC is considering expanding the number of sports on the programme which might open the door for squash to participate.
- PSA and WSA have amalgamated.

#### **OCEANIA REPORT**

Jim O'Grady, Vice President of the Oceania Squash Federation, provided an update on the activities in the Oceania region. With assistance from the CWG Federation Oceania had conducted an ambassador's programme in Papua New Guinea in 2014. A further programme would be held in Fiji later in 2014 including coach development and training.

Papua New Guinea was now a full member of WSF and Tahiti had now become affiliated to Oceania Squash Federation. In 2015 the Oceania Junior Championships will be held in Invercargill, the Youth Commonwealth Games will be held in Samoa and PNG will hold the Pacific Games with new courts planned for this event.

Neven Barbour was re-elected to the OSF Executive along with Jim O'Grady (NZ) and Vicki Cardwell (Australia).

#### **GENERAL BUSINESS**

Susie Simcock gave an update on the World Masters Games to be held in Auckland in 2017. More than 25,000 competitors were expected and squash was one of the core sport. The squash competition would be held at the Northshore Squash Club.

Grant Smith advised that in 2015 the very successful PSA series was being expanded to include 3 x WSA events at the same locations as 2014.

Vicki Cardwell (Squash Australia) thanked SNZ for the opportunity to attend the AGM and the about developing closer relationships between the two countries.

Willie Bicknell asked what SNZ would be doing about a national campaign for 2015. It was explained that this would be contingent on the new roles within the national office. He also expressed a wish to see events such as the Hall of Fame dinner opened up to younger people so they could enjoy what these events had to offer.

## **SPECIAL AWARD**

A special presentation was made to Rob Walker from Club Kelburn for 20 years of service and dedication to Squash New Zealand. This was endorsed by Bill Murphy who also acknowledged the contribution that Rob Walker had made to the sport.
